Bow Wag's Policies, Procedures and Wagger Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement

In consideration for my dog being permitted to be a client "Bow Wagger" at Bow Wag's for day or overnight boarding, I make the following representations and agree to all of the following policies, procedures, terms and conditions:

1. **Bow Wagger requirements.** My Bow Wagger meets the following requirements: he/she has completed the temperament test, is 4 months old or older, is spayed/neutered (if over 6 months), is current on his/her Rabies, Distemper and Bordetella vaccinations, is in good general health with no flea or tick issues, is not aggressive or protective over toys, people or other situations. My Bow Wagger will wear a quick release collar with identification and will enter and exit Bow Wag's on a leash.
2. **Bow Wag's food.** I understand that my Bow Wagger will not be fed lunch. If I wish for my dog to be fed, I must bring a marked container with my dog's name and feeding instructions.
3. **Personal Property.** I agree that Bow Wag's will not be held responsible or liable for any lost, stolen or damaged personal property belonging to my Bow Wagger. I understand that my Bow Wagger's collar may be removed during the day during play to prevent injury to any other dog. If my Bow Wagger causes any damages to Bow Wag's facility or equipment, I agree to be fully responsible for the full cost of any repair or replacement.
4. **Cancellation Policy.** I understand that I will be charged for a full day of Camp if I fail to cancel my dayCare reservation 24 hours in advance. I further understand that I will be charged a full day of boarding if I fail to cancel my boarding reservation 48 hours in advance. If my reservation is within 3 days of a holiday, I understand that I will be charged 2 full days of boarding if I fail to cancel my reservation 72 hours in advance.
5. **Abandoned Dogs.** No Bow Wagger may be abandoned at Bow Wag's. I agree that I will not neglect to pick up my Bow Wagger from dayCare by the time he/she is scheduled to leave without prior notification. If any Bow Wagger is neglected for 7 days, he/she will be considered abandoned and Bow Wag's will become the legal owner of the Bow Wagger. **I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT BOW WAG'S, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST BOW WAG'S.**
6. **Duty to Disclose.** I have disclosed and will continue to disclose on an on going basis any and all medical conditions and medications, including personal concerns that may affect my Bow Wagger's play time.
7. **ACCEPTANCE AND ACKNOWLEDGEMENT OF CAMP PARTICIPATION RISK.**

I fully understand that there are inherent and potential risks involved with interactions between humans and dogs, as well as between dogs and other dogs, which may result in property damage or bodily injury, including, but not limited to: permanent disability, sickness or death to human or dog, AND there may be other risks not known to me nor readily foreseeable at this time (collectively "risks"). I fully accept and assume all risks and responsibility for all risks, including, without limitation, all losses, costs, and damages incurred as a result of my Wagger's participation in dayCare including all veterinarian expenses incurred on behalf of my dog. Sickness shall be defined to include any illness including but not limited to Bordetella (Kennel Cough) or any other form of contagious illness.

8. **Veterinarian Liability and Care.** I agree to allow Bow Wag's to obtain medical treatment for my Wagger, if, in its sole discretion it appears that he/she is ill, injured or exhibits any other behavior that would reasonable suggest that my Wagger needed medical treatment. If a Wagger passes away at dayCare, it will be brought to the nearest Veterinarian. I agree that I am fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment, provided to my Camper.

9. **Waiver, Release and indemnification.** I hereby expressly and forever generally waive, discharge claims, indemnify release from liability, save, hold harmless Bow Wag's from **ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS OF EVERY PERSON WHATSOEVER** on account of, rising out of, resulting from or relating to in any way, any action or omission of the Releases, including negligence, and my Bow Wagger's participation in activities at Bow Wag's, or otherwise. I further agree to indemnify, save and hold harmless the Releases from any claims, litigation, actions, suits, damages, costs, losses or injuries as a result of any such claim.

I have read and fully understand the terms of this "Bow Wag's Policies, Procedures and Wagger Release, Waiver of Liability, Assumption of Risk and Indemnification Agreement and understand that I have given up substantial rights by signing it and have signed it freely and voluntarily without any inducement, assurance or guarantee and intend it to be a complete and unconditional release of all liability to the greatest extent permitted by law and agree that if any portion of this agreement is held to be invalid or unenforceable, that the remainder of this agreement shall remain in full force and effect. I agree that it is intended that all terms of this agreement control despite any particular statute or law that would otherwise protect me or my dog(s).
